SCAD'S COVID-19 POLICIES

As we look to offer lessons this season, SCAD must comply with certain federal, state, and local guidelines and must work to insure the safety of our skaters, our coaches and our community. We ask for your help following those guidelines. SCAD may change the policies and protocols described in this document depending on public health and state/federal/local guidance and such changes will be considered binding. SCAD will provide notice to all members of any such changes and thanks you for your cooperation and your ongoing support of SCAD.

General safety measures being implemented this season:

- 1. Campion will clean benches, gates, seats, scorekeepers box, bathrooms, lobby doors and all high touch areas between groups.
- 2. On Thursdays, SCAD will clean the top of the boards in both players boxes between groups.
- 3. We have chosen to impose ice restrictions for this season, and thus SCAD is restricting the total number of people on the ice to 25 including total number of skaters and coaches.
- 4. Beginner classes (all levels of Snowplow Sam and Basic 1), which involve high-contact with the younger skaters, are not currently being offered.

Guidelines for skaters:

- 1. Please do not come to skate if you are experiencing any of the symptoms associated with COVID-19 infection (including elevated temperature, cough, shortness of breath, sore throat, among others).
- 2. Both Campion and SCAD require each skater to complete a COVID-19 waiver for the 2020-21 season. Campion's waiver will be available at sign-in on the first day of lessons or can be downloaded here. SCAD's general waiver and COVID-19 waiver consent will be agreed upon during the registration process.
- 3. All people entering the building will need to complete a wellness screening for Campion Rink each time they enter the building. You can download the form here.
- 4. Skaters may not participate if they have been outside of New England (NH, VT, ME, MA, RI, CT) for families who are NH residents or to

- quarantine counties within states that are not allowed by Vermont guidelines for families who are VT residents within the last 14 days.
- 5. Skaters should come dressed and ready to skate (with the only exception being that skates may be put on in the lobby). Changing rooms will not be open. Everyone entering Campion must wear a mask and keep it on while in Campion. All skaters must wear a mask while on the ice.
- 6. There are NO spectators allowed in the building. If your child requires help with their skates, one person will be allowed to come in to assist them and must leave once skater is on the ice.
- 7. Skaters will be allowed to enter Campion 10 minutes before their scheduled lesson. Skaters will enter the lobby doors. If there is a line to enter the lobby, please allow six feet between you and the person next to you in line. In the lobby, a Campion employee will ask screening questions and everyone entering will need to have a signed entry screening and wellness certificate signed.
- 8. Skaters will exit Campion by the side door and within 10 mins of the end of their ice time. Parents please be present to collect your child at the end of their session. They will NOT be allowed to stay in building.
- 9. In the event any SCAD skater tests positive for COVID-19, or finds they were exposed to someone with COVID-19 within 14 days of a skating session, said skater or parent/guardian shall inform SCAD thereof at: sk8info@skatingclubatdartmouth.org.
